## Additional Information

### Current Price

Prices shown are based on GSE closing prices on the date of the report. Prices may change in the days following publication due to ongoing market activity.

### Liquidity Score

The Liquidity Score is a simple measure of how available a stock has been for trade without significantly affecting its price within the 1-week period preceding the report.

### How the Liquidity Score is calculated:

The score is based on

- **Trading activity** - frequency, number and size of trades
- **Market depth** - availability of buy and sell orders
- **Quote availability** - consistency of price quotations

### Year to Date Performance

YTD Performance- The percentage change between the current price and the price at the start of the year

### Market Position

Market position is based on the stock's standing in the market relative to buying and selling pressure, determined by the bid and offer volumes posted on the GSE

**Net Bid** - When total bid volume exceeds total offer volume

**Net Offered** - When total offer volume exceeds total bid volume
